TERMS AND CONDITIONS OF ACCREDITATION

- 1 Any holder of an FIA or ASS credential will be accredited automatically by simply returning this form completed.
- 2 All other requests of an accreditation must be accompanied by a letter from the chief editor or from the director of the media.
- 3 Free Lance journalists or photographers will be asked to prove that they are actually working on the rally (press cuttings or letter from the chief editor of a publication).
- 4 By signing this form, the applicant acknowledges that the organisers of the event will not be liable for any injury / death, damage or loss of property which may be sustained or incurred as a result of his participation in the event. When collecting his/her credentials, each journalist or photographer **MUST** sign a waiver. The applicant acknowledges that he is aware that motor sport can be dangerous. **The applicant's activities during the 59th Rallye International du Valais must be covered by a valid third-party insurance contract**
Except upon special agreement - e.g. for TV crews - the accreditations cannot be collected by a third party
- 5 The organisers will provide a maximum of one car sticker and two credentials per request, upon showing proof that the second person is actually working, with the exception of TV and radio crews (please attach a list of persons to be accredited with their respective function).
- 6 The organisers reserve the right to refuse accreditation without having to give the reason.
Applications received after October 12th, 2018 will not be considered

7 The press stickers, credentials and tabards* will be issued at the Media Centre, **Casernes, Rue des Casernes, 1950 Sion** on October 18th, 2018 from 10:00am to 6:30pm

8 These conditions are part of the accreditation application and must be duly completed and signed. Incomplete applications will not be considered.

**It is compulsory to wear the tabard to access some restricted areas, especially in the special stages. Any member of the press failing to wear the tabard will automatically be denied access to these areas by the marshals on duty. Each tabard is numbered and can only be worn by the person to whom it has been allocated. The tabard must be accompanied by a valid Media credential.*

A deposit of 50 CHF (or 50 €) per tabard is required when collecting the tabard(s)

Credentials, car stickers and tabards are NOT transmissible. If for any reason, an accredited journalist or photographer must be replaced by another person, this one must report to the Media Centre in order to obtain a credential at his/her name.

Non-compliance with the rules or refusal to obey the marshals' instructions will result in the immediate withdrawal of the credentials
